INSTRUCTIONS FOR TAXICAB DRIVER

AGREEMENT/CHECK-OFF REQUIREMENTS

Upon receipt of the application, drivers agree to submit to the following requirements and to comply with all the laws, rules, and regulations pursuant to MTDB's Uniform Paratransit Ordinance.

Fraudulent, false, or misleading information will result in the denial of the Identification Card. Failure to comply or violation of the laws and regulations set forth by MTDB will be the basis for recommending denial, suspension or revocation and are subject to the General Managers Administrative Process and/or action.

Applications are accepted at the Sheriff's Administrative Center, License & Criminal Registration Division. Drug and alcohol tests must be received by our office before we can start the process. We highly recommend you call to make sure we have the results prior to coming to the office. Current business hours are located on our website, or you may call (858) 974-2020.

REQUIRED DOCUMENTS

1. **Completed Taxicab Driver's application.**
2. **Valid California Driver License**
3. **Safety Certificate** (DQE Certificate) from MTS
4. **Valid Business Tax Certificate** if picking up in the City of San Diego
5. **Substance abuse test results and alcohol test results** - must be received by the Sheriff's Department BEFORE application will be accepted. Positive results may affect the approval of this license. Both tests are only valid for up to 30 days after the collection date.
6. **If not born in the United States**, driver must provide a valid Alien Registration Card, Employment Authorization card, Certificate of Naturalization or U.S. Passport.
7. **Hire Slip must be SIGNED AND DATED by an authorized signer of the Taxicab company.**
The company must be registered with the Sheriff's Licensing & Criminal Registration Division and the authorized signature must be on file. An original signature is required on the Hire Slip and it must be dated by the authorized signer within seven business days of the date the driver comes into our office. Drivers cannot write the date on their own Hire Slip unless they are also an owner and authorized signer of the company.
8. **\$49.00 Live Scan Fee*** required for Initial applications or if a current driver has allowed the permit to expire by 30 days or more. A license that is 30 days or more expired requires the driver to reapply for a new license and be live scanned again.
9. **\$121.00 Processing Fee*** FOR INITIAL AND REAPPLY DRIVERS

*Fees are payable by cash, check or debit/credit card. An additional fee is charged for payments made by debit or credit. The fees are \$2.50 if paying by debit and \$3.00 if paying by credit card.
