Domestic violence is as a pattern of behavior in a relationship that is used to gain or maintain power and control over an intimate partner. An intimate partner is a current or former spouse, cohabitant, dating or engaged relationship, or person with whom one is having or has a child with. Domestic violence by a person known to you, including your spouse, is a crime. Law enforcement may make an arrest of your abuser without your cooperation pursuant to California Penal Code Section 13701(b). You may contact the District Attorney or City Attorney to file a criminal complaint.

Abuse can be physical, sexual, emotional, economic or psychological actions or threats of actions that influence another person. This includes any behaviors that frighten, intimidate, terrorize, manipulate, hurt, humiliate, blame, or injure someone. Domestic violence victims come from every age group, gender, religion, ethnic/racial group, socioeconomic level, educational level and sexual orientation.

AND can cause serious internal injuries. Strangulation has been identified as one of the most lethal forms of domestic violence. Unconsciousness may occur within seconds and death within minutes. If someone has placed anything around or against your neck, you should seek medical attention immediately. If you or someone you know has been strangled or suffocated, CALL 911.

Sexual Assault by a person who is known to you, including sexual assault by your spouse, is a crime. If you are sexually assaulted, call 911 immediately or go to the nearest hospital and request a Sexual Assault Response Team (SART) exam. Please DO NOT wash, shower, douche, change clothes or brush your teeth. A forensic nurse examiner specially trained to provide an evidentiary exam, a law enforcement officer to conduct an investigation, and a victim advocate for emotional support will be available to



Your abuser may be released from custody at anytime! Register to be notified of an inmates release or facility transfer status through "Victim Information and Notification Everyday" or VINE. Call VINE toll-free at (866) 277-7477 or visit on the web at www.vinelink.com

You have the right to file a civil suit for losses suffered as a result of the abuse, including medical expenses, loss of earnings, and other expenses for injuries sustained and damage to property, and any other related expenses incurred by you or any agency that shelters you. For further information about a shelter you may contact resources on this pamphlet.

You have the right receive an

Emergency Protective Order or to go to the

Superior Court and file a petition requesting
any of the following court orders for relief:

- Restraining your attacker from abusing you or any other family member.
- Directing your attacker to leave your household and preventing your attacker from entering your residence, school, business or place of employment.
- Awarding you or the other parent custody of, or visitation with, your minor child or children and directing the party not granted custody, to pay support of minor children, if that party has a legal obligation to do so.
- Restraining your attacker from molesting or interfering with minor children in your custody.
- Directing the defendant to make specified debit payments coming due while the order is in effect.
- Directing that either or both parties participate in counseling.
